Sinergi dan Kolaborasi untuk Akselerasi Layanan Dasar (SKALA)

Indonesia

2022-2026, DFAT

SKALA accelerates improved service delivery in less developed regions of Indonesia at the subnational and local level, with a focus on ensuring better access for Indonesia's vulnerable groups, including women and people with disabilities. This project supports subnational governments' capacity to implement and deliver basic services for communities. It does so by strengthening parts of Indonesia's decentralized governance system, such as public financial management; minimum service standards; and mainstreaming gender equality, disability, and social inclusion.

Australia Indonesia Partnership for Economic Development (Prospera)

Indonesia

2018-2026, DFAT

Prospera supports the Indonesian government across three areas—expanding markets to create jobs, safeguarding economic and financial stability, and improving public finances and government performance—to safeguard economic stability and pave the way to transform into a high-income economy by 2045. The project supports 30 Indonesian government agencies to strengthen public finance management and increase revenue via improved tax administration and policy, and improved budget systems. PROSPERA also contributes to Indonesia's system for policy development by advising agencies on economic governance through more than 100 embedded advisors.

Indonesia Australia Partnership for Infrastructure (KIAT)

Indonesia

2016-2026, DFAT

KIAT is a partnership between the governments of Indonesia and Australia to support sustainable and inclusive economic growth through improved access to infrastructure for all people. The project works with government bodies at national and sub-national levels to provide short and long-term technical assistance and advisory services to improve infrastructure policy, planning, and delivery. To help improve infrastructure policies and regulations, KIAT mainstreams gender equality, disability, and social inclusion across all activities and engages with civil society to strengthen infrastructure outcomes. It

supports activities in the transport, water, and sanitation sectors, and assists the government to attract private sector investment to bridge the infrastructure financing gap.

PROSIVU

Timor-Leste

2022-2026, DFAT

PROSIVU supports good governance and economic policy development and assists Timor-Leste's central government agencies and economic line ministries. The project works with the Government of Timor-Leste, civil society, and the private sector on priority economic reforms to grow and diversify the economy. PROSIVU's goal is to support the government to achieve the social and development outcomes from its Strategic Development Plan, including promoting more inclusive economic growth, sustaining public finances, and enhancing public administration.

Support Unit-Advisor Team and Facility Program (SLSU)

Sri Lanka

2019-2023, DFAT

SLSU assists the DFAT bilateral aid program to transition into a set of strategic, long-term economic and governance partnerships between Australia and Sri Lanka. The project supports an advisory team that provides strategic advice to the bilateral aid program on monitoring, evaluation, and learning; gender, equality, and social inclusion; governance; economics and the private sector; communications for change; food security, and agriculture and aquaculture. SLSU also assists DFAT to implement the Knowledge and Linkages for an Inclusive Economy grants program for government-to-government, professional, and research linkages between Sri Lanka and Australia.

Aus4Transport

Vietnam

2018-2024, DFAT

Aus4Transport increases investment in Vietnam's transport infrastructure, leading to an improved national transport network that supports economic growth and poverty reduction. Working closely with the Ministry of Transport and the wider transport sector, Aus4Transport is improving the sector's capacity to design and develop high quality projects and bring them to market faster, making the sector more attractive to private investors and multilateral development banks.

Partnership to Strengthen Village Development and Municipal Administration (PARTISIPA)

Timor-Leste

2021-2026, DFAT

PARTISIPA is strengthening government institutions to deliver quality public services that are accessible to all and supporting the resilience of communities through broad-based participation, economic opportunity, and improved village infrastructure. The project works with the Ministry of State Administration and Territorial Management at the municipal level to strengthen decentralization. PARTISIPA also supports operations and maintenance for community-based infrastructure, particularly in the water sector.

ASEAN-Australia Counter-Trafficking (ASEAN-ACT)

Southeast Asia

2018-2023, DFAT

ASEAN-ACT is contributing to the development of effective justice systems that provide just punishment of traffickers and protect the rights of victims of trafficking in persons in ASEAN member states. The project works with a range of ASEAN sectoral bodies and organs on region-wide initiatives that include all ASEAN member states. Since 2021, ASEAN-ACT has partnered with nine NGOs to promote inclusive policy dialogue and learning between diverse stakeholders in the region.

Rural Access Programme (RAP)

Nepal

2017-2023, FCDO

The Rural Access Programme in Nepal is responsible for the design, build, and project management of road maintenance, road improvement, and new road construction activities. These construction activities provide an entry point for poverty alleviation in some of the poorest parts of Nepal. The work applies a pro-poor approach to road construction and maintenance to provide climate resilient roads and bridges in two of the most remote districts of the country: Mugu and Humla. RAP employs a hybrid construction approach that provides income to underserved people in Nepal and trains local and provincial government bodies to maintain road access and support emergency and humanitarian responses.

TA to Support the Implementation of the Education and Sport Sector Development Plan

Lao PDR

2021-2024, European Commission

The project works with the Lao PDR Ministry of Education and Sports on planning and budgeting and supports capacity development for education managers and administrators. The project also provides technical support to the Ministry of Education and Sports, training for Ministry trainers, and knowledge exchange with ASEAN countries.

Subatra Justice and Society Project

The Philippines

2022-2025, AECID (Spanish Agency for International Development Cooperation)

Subatra lays the foundation for sustainable, functional, responsive, and equitable justice in the Bangsamoro Autonomous Region of the Philippines. The project provides technical assistance to identify, provide inputs on, and draft priority laws. It identifies boundaries of the justice systems, including laws and procedures for challenging and appealing decisions that may violate human rights.

Technical Assistance to Support the Implementation of the PFM Reform Strategic Plan

Bangladesh

2020-2024, European Commission

The project provides capacity building to strengthen the National Board of Revenue, the Office of the Comptroller and Auditor General, and the National Parliament to implement strategic reform priorities around domestic revenue mobilization and domestic accountability. The goal is to strengthen these entities and improve tax collection, revenue governance, quality and timeliness of external audits, and parliamentary oversight.

Avansa Agrikultura Project

Timor-Leste

2015-2021, USAID

Avansa was a horticulture value chain activity that addressed rural poverty, natural resource degradation, food insecurity, and under-nutrition to accelerate sustainable and inclusive economic growth. The project increased productivity along horticulture value chains and promoted sustainable production practices, supported farmer groups, improved market linkages, increased availability of quality agricultural services, and increased climate change resilience and natural resource management.

The Cambodia Agricultural Value Chain Program Phase 2 (CAVACII)

Cambodia

2016-2022, DFAT

CAVACII increased the productivity and incomes of the small farmers and trade in milled rice and other crops by strengthening market systems and investing in irrigation infrastructure. The program was based on the Making Markets Work for the Poor principles and improved the efficiency and effectiveness of markets that provide goods and services to benefit farmers.

Accelerating Public and Private Investment in Infrastructure (APPIIC)

Nepal

2016-2023, FCDO

APPIIC increases investment in infrastructure to accelerate economic growth and expand job opportunities. The project provides technical assistance to the Government of Nepal to address weak energy and transport infrastructure. This work has led to a significant investment increase (US \$2.5 billion) in large scale growth enhancing infrastructure that supports economic growth and expands job opportunities.

MCA Fiscal Agent Services

Nepal

2017-2025, MCA

DT Global is a highly experienced Fiscal Agent (financial management for MCC-funded Compacts). In Nepal, DT Global manages the \$500 million Compact to increase the availability of electricity and lower the cost of transportation.

Collaborative Fisheries Management (Ber-IKAN)

Indonesia

2022-2027, USAID

Ber-IKAN advances Indonesia's self-reliance to protect marine biodiversity by improving sustainable and equitable fisheries management. As a subcontractor, DT Global leads gender equity and social inclusion mainstreaming, institutional strengthening, and capacity building activities. DT Global also strengthens integrated, effective marine and fisheries surveillance and enforcement at province and community levels.

Public Investment Facility for Infrastructure Constraints (PIFIC)

Bangladesh

2019-2023, World Bank

PIFIC is a component of the Ministry of Commerce of the Government of Bangladesh 'Export Competitiveness for Jobs' project that provided technical assistance to infrastructure. The project developed an infrastructure pipeline and operated as a filtering, prioritization, and selection mechanism for projects that addressed industry-specific infrastructure constraints for clusters of Bangladeshi enterprises.

EU-Thailand Cooperation Facility (EUTCF)

Thailand

EUTCF enhances the EU-Thailand partnership across political affairs, trade and investment, sustainable business, environment and climate change, biodiversity and natural resources, good governance, human rights, security, gender equality, women and youth empowerment, and science and research. The Facility supports deepening diplomatic ties; knowledge and expertise sharing; the smooth conduct of business, trade, and commerce; and cooperation on shared areas of interest.
