Commitment to Achieving Net Zero

DT Global UK is committed to achieving Net Zero emissions by 2050.

Baseline Emissions Footprint

Baseline Year: 2019

Additional Details relating to the Baseline Emissions calculations:

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

DT Global UK selected 2019 as the baseline year for the companies carbon footprint, as 2020 had been severely affected by Covid-19. DT Global UK undertakes annual emissions reporting across all locations under its registered entity.

Baseline data was collected prior to the acquisition of IMC Worldwide Ltd and included carbon emissions from the main offices in Redhill, UK, Washington DC, USA, and Malaga, Spain. Project offices and project-level emissions were not included in the baseline.


Emissions Reduction Targets

DT Global UK has made a commitment to be a net zero organisation by 2050.


To achieve net zero emissions in our operations by 2050 we have set interim targets for greenhouse gas emission reduction from the 2019 baseline carbon footprint of:

- 46% reduction by 2025
- 67% reduction by 2030
- 80% reduction by 2035
- 100% reduction by 2050

Progress against these targets can be seen in the graph below:

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline:

- We established a Net Zero Group with responsibility for driving activities to reduce our emissions. The Group reports on progress to our Senior Leadership Team.
- Mainstreamed carbon reduction processes into the Quality Management System (QMS) and Environmental Management System (EMS).

Further Possible Reduction Initiatives

In the future we hope to implement further measures such as:

- Extend baseline reporting to include all corporate operations including in-country project emissions in-line with government action.
- Introduce carbon awareness and management training for all staff, including project staff.
- Reflect carbon emissions reduction commitments in employee policies.
- Develop a DT Global UK strategy for delivering carbon neutral projects.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard3 and uses the appropriate Government emission conversion factors for greenhouse gas company reporting 4.

Scope 1 and Scope 2 emissions have been reported in accordance with Streamlined Energy and Carbon Reporting (SECR) requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard 5.

This Carbon Reduction Plan 2022 Annual Progress Update has been reviewed and signed off by the Managing Director.
